According to Article 87 paragraph 1 of the Law on Environment ("Official Gazette of the Republic of Macedonia" no. 53/2005, 81/2005, 24/2007, 159/2008, 83/2009, 48/2010, 124/2010, 51/2011, 123/2012, 93/2013, 42/2014, 44/2015, 129/2015 and 36/2016), the Minister of Environment and Physical planning brought

D E C I S I O N

1. With this Decision Approval is given for the application of implementation the project – Construction and reconstruction of collector and sewer systems and construction of waste water treatment plant for agglomeration in Tetovo, for the needs of the investor Ministry of environment and physical planning.
2. The EIA Study from the project – Construction and reconstruction of collector and sewer systems and construction of waste water treatment plant for agglomeration in Tetovo, meets the requirements for environmental protection by applying measures to prevent and reduce the harmful effects on the environment, by obligating the developer to clearly implement the management plans and environmental monitoring.
3. This Decision shall enter into force on the day of its adoption and shall be published within five working days from the date of adoption in at least one daily newspaper available throughout the territory of the Republic of Macedonia, the web page, as well as on the bulletin board in the Ministry of environment and physical planning.

Explanation

The Investor Ministry of environment and physical planning on day 09.01.2017 has delivered the EIA Study for the project: Construction and reconstruction of collector and sewer systems and construction of waste water treatment plant for agglomeration in Tetovo, prepared by Marijan Mihajlov as responsible person for preparation of the EIA study and expert on project impact assessment on the environment, for the needs of the investor Ministry of environment and physical planning.

With the project the investor foreseen construction and reconstruction of collector and sewer system and construction of waste water treatment plant for agglomeration in Tetovo.

In the Study are analyzed the possible impacts in the construction and operational phase as: topography, geology, hydrogeology, surface and underground waters, air, water, soil, erosion, noise, waste, flora and fauna, landscape and visual effects, social elements on environment, archeological and cultural and historical heritage and cumulative impacts and are reviewed the possible alternative locations for construction of the project.

According to Article 91 of the Law on Environment ("Official Gazette of the Republic of Macedonia" no. 53/2005, 81/2005, 24/2007, 159/2008, 83/2009, 48/2010, 124/2010, 51/2011, 123/2012, 93/2013, 42/2014, 44/2015, 129/2015 and 39/2016), public hearing for the EIA study of the project construction of waste water treatment plant for agglomeration in Tetovo was held on 10.02.2017 in the Municipality of Tetovo at 10:00 am.

The Commission for preparation of the report on the appropriateness of the EIA study of the project – Construction and reconstruction of collector and sewer systems and construction of waste water treatment plant for agglomeration in Tetovo, formed by the Minister of environment and physical planning, after conducting a public hearing, in accordance with the Regulation on the form, content, procedure and manner of preparation the report for appropriateness of the EIA study of the project ("Official Gazette" no. 33/2006) has prepared a Report and delivered to the Minister for environment and physical planning.

The Commission for preparation of the report on appropriateness of the EIA Study of the project – Construction and reconstruction of collector and sewer systems and construction of waste water treatment plant for agglomeration in Tetovo, considered the sources and types of possible degradation and pollution on the basis of which measures for protection the main environmental media are dimensioned and defined.

The designed protective measures to prevent and reduce the environmental impacts are applicable and will meet the basic requirements. The report was published in two daily newspapers available throughout the territory of the Republic of Macedonia.

Based on the above stated it is decided as in the operative part of this Decision.

Legal advice: Against this Decision, the Investor, the concerned legal and physical entities, as well as the Association of Citizens formed for protection and improvement of environment, may submit an appeal to the State commission for administrative decisions within a period of 15 (fifteen days) from the day of the last publishing of the Decision according to the Article 90 paragraph (1) point 5 from the Law on Environment.
